6. Business Arising:

- 6.1. Anti-Bullying and Anti-Violence (ABAV) Plan:
 - Similar to previous years. Talks about what anti-bullying and anti-violence means. New element added to stop sexual violence. Updated to reflect Bill 9 Obligation to the Quebec Education Act. We take a survey at the school level yearly. We have fewer acts of bullying then the Canadian norm. We need to continue our work on this matter. There are prevention measures, and training for students and staff. Priorities and prevention. Promote EDDI, and ensuring wellness Clearpoint will have student/teacher/staff/governing board involved.
 - We still have peaceful school initiatives and have many strategies to target positive actions taken by students. We have days (pink shirt, orange shirt) to bring awareness, and recess heroes (students to help with conflict resolution).
 - Ongoing conversations with students and parents until the conflict is resolved.
 - There are follow ups to ensure victim of bullying is well taken care of.
 - Code of conduct and ABAV plan on Clearpoint website for parents to review. There are resources for parents and students.
 - Goal is to eliminate bullying and violence, so we need parents committed to the goals of this plan.
 - Outlines roles and responsibilities of all parties, and a guide to register complaints.
 Establishes procedures measures that staff, and principal, will take when an incident takes place.
 - Encourage everyone to speak up if anyone sees anything.
 - Discretion, empathy, confidential.
 - Reviewed annually, reports are kept confidential.
 - We support victims, by ensuring caring and safe environment put measures in places to help those FSST DYP.
 - Must consider age and maturity when dealing with consequences. Frequency, severity, context for the situation, and family context are all considered for disciplinary actions.
 - Each incident is followed up and documented, monitoring of students, disciplinary actions, parents can make a complaint if they are unhappy with the results.
 - It is important for parents to understand the limitations that staff has in these situations. Strict legal guidelines govern for the staff to protect all children involved. It would be helpful to communication this with the parent community.
 - Incident reports are a metric for how our ABAV plan is working.

- School website has audited financial available.
- It looks like we have surplus, but we have an accounting rule for asset retirement, we have an obligation to inventory our buildings to determine which had asbestos, oil and septic tanks, need to account for how much it would cost if we did repairs today, so this surplus is not a realistic snapshot. There was a 10 million error with accounting software, so we are actually still in the red.
- 19 schools that applied to green grants, out of 19 we had 14 receive \$5,000 grants.
